#### **OLD BUSINESS:**

Gem Show – Ed Skidmore – They need volunteers to step up and help. Sandy Skidmore says they are working on the paperwork that Debbie Berresford has. She knows there are problems but is rectifying them. 11/21/15 and 11/22/15. Set up is on Friday. Tina La Bau says the pups volunteered to sell raffle tickets.

Security Committee: Sandy Skidmore will get with Tina La Bau and Ruben Martinez to set a date.

#### **NEW BUSINESS:**

CFMS – Tina LaBau stated that the CFMS Lodi trip is coming. She is requesting certain expenses in advance: The cost for dinner is \$35; mileage is 371 miles each way, \$15 for each day plus Holiday Inn Express at \$150 each night if booked early for June 11th and 12th. She has to pay for dinner now and book hotel. Amount budgeted for CFMS is \$500. Barbara Pedrow understood that was a reimbursement. Cyndy Mandell says there is a policy in place. The issue is tabled to be discussed later.

Tina/Debbie/Discussion – Marc says that by-laws state that parties will call you out if you do not follow the letter of the law. The money is not to be advanced. Members asked that application be submitted with expenses. The concern is audit issues. Tina said she would table it for now.

Donations – Debbie Berresford: Tool Box, the Board needs to decide what to do with it. Sandy said the pixie could be used for the raffle drawing. A motion was made to use the donated pixie for Gem Show Raffle and the tool box as a drawing item. Sandy/Steve/Discussion 7 approved, 2 opposed, 2 abstained. Motion carried

Frank Duncan made a motion to have a committee formed to deal with disciplinary action. Table current issues until committee formed. Terry Booth stated that the by-laws have a method for dealing with issues. Issue tabled to end of meeting for further discussion.

Gil Gilbert – At General Meeting: some issues were addressed. A special meeting was held to address the issues that were on the board. The issues will be addressed further in executive meeting. Cyndy Mandell states that by-laws cannot be discussed in a special meeting according to CFMS. Marc Smith states that the President has the right to call a closed session. The by-laws are discussed at committee then brought to a regular meeting. She states that we did it inappropriately. Marc Smith stated that we voted on merit/no merit and sent to by-laws committee to deal with. Additional discussion ensued.

Frank said that Cyndy Mandell said that they did not have complaints but concerns. Cyndy Mandell requested that Tina LaBau and Marc Smith read umbrella CFMS rules. Cyndy Mandell says she has given them out. No one has ever seen or heard about them. She stated that Marc Smith could go to CFMS.inc.org - Robert's Rules of Order are general, CFMS umbrella by-laws, then our by-laws. Tina La Bau asked about the order of rules we are to follow.

Terry Booth asked for the reading of Minutes of regular board Meeting 4/7/15. They are located in the book and presented in the Newsletter. A motion was made to approve the minutes. Debbie/Frank/Approved 1 abstain

Debbie Berresford had a concern regarding By-laws. Section 12 procedure states that we are governed by Robert's Rules of Order. Sandy Skidmore didn't think CFMS rules should be in the by-laws. Marc Smith wanted to make it as an agenda item for next month. He invited education on the issue; Cyndy Mandell will provide him a name.

Yo Simpson says we are to go by the CFMS by-laws, we are bound by their by-laws by virtue of our membership with them. Tina La Bau stated that someone called Tom Burchard from CFMS said CFMS does not intervene in our clubs affairs and he stated that they do not get involved. Cyndy Mandell says she called for advice for rules and regulations. She knows they don't intercede and to stop inflammatory remarks. Barbara Pedrow wants the issue dropped to another time when there is more information.

Treasurers Report: Craig Britt states, "He has tweaked it and has made some changes and believes that he has it correct". He put a transaction report that encompasses deposits and checks together in one report rather than two separate reports. Audit committee meeting on Wednesday 5/13/15 published in newsletter. Last page of spreadsheet, Cyndy says the balance is missing on the income and expense of budget.


#### LIME STREET SCHOOL by Cyndy Mandell


