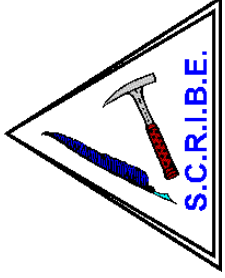

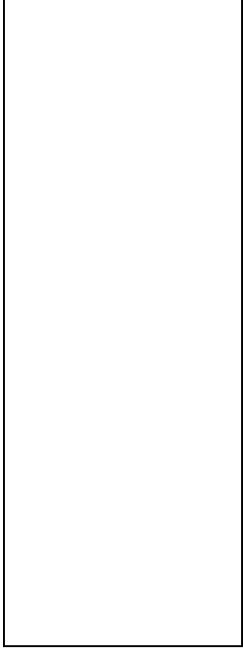

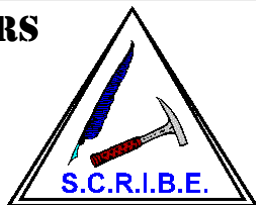
needs materials to put this display together.

CFMS Directors' Meeting

Report by Janet Flecher

On November 8, 9 and 10, I traveled to Visalia for the annual Directors' Meeting of the CFMS (California Federation of Mineral Societies). This is one of two annual meetings that our club is required to send a representative to. The other meeting occurs on the Saturday of the CFMS annual Gem and Mineral Show.

Both CFMS and AFMS are in the forefront of the struggle to preserve rock hounding across the country. CFMS sponsors field trips open to all members of the CFMS; it puts on two world class educational programs every year. One week at ZZZZX in the desert out by Baker and the second a two week program in Northern California called Camp Paradise.

The real focus for being a member of the CFMS is something completely different. And that is insurance. The VVGMC has to carry two completely different types of liability insurance. The first type is insurance on our buildings and property. The second type of liability insurance that we, the VVGMC, must carry is insurance on our activities; the same insurance that allows us to host show events and, most importantly, our field trips.

Around the "turn of the century" (loved saying it that way) there was an accident on a field trip sponsored by one of the CFMS clubs. On this specific trip, a man was digging under a very large overhang. He was asked three or four times to stop digging at that specific site, and refused. The worst case followed, the overhang collapsed and the accident was fatal. This incident was sufficient that every insurance company in California who offered liability insurance for club sponsored field trips rescinded their coverage. That left all 120 odd clubs that make up the CFMS with no insurance for trips and shows of any kind. At this point, the CFMS came to the forefront and decided that they needed to take a lead position in finding replacement insurance for the clubs. After an exhausted search, the CFMS found one insurance company who would write a policy to cover what the insurance companies see as recreational mining. And since this accident this is the only company who sells insurance in California who will sell a policy to cover our club activities. And this company insists that the CFMS clubs band together and purchase just one policy, rather than writing policies to 120 odd clubs.

At present, this policy costs each club \$6.50 per member as of January 1 of every year. The CFMS officials who handle this

The first of the year is rapidly approaching and it will be time to pay your yearly dues again. Let's get an early start and pay now so we can avoid the \$5.00 penalty after January 1st. \$5.00 Petrified Pups; \$20.00 individual and \$30.00 for couples.

policy professionally (two insurance agents and a lawyer) do attempt every year to find a second company to bid against the insurance company that the CFMS have used since the accident, but none have come forth and offered to bid on the policy. And the cost of the insurance to the CFMS and onto to us, the VVGMC has been rising. In the last ten years the cost of this insurance has risen from \$1.50 per club member to \$6.50 per member.

Our (the VVGMC) commitment to the CFMS is twofold. First we, through our membership, in the CFMS commit to paying the yearly dues required by the CFMS (\$8 per year per individual). Part of these funds is sent to the AFMS and the balance (after the insurance premium is paid) goes to the operation of the CFMS. The second part is that we (again the VVGMC) have to provide a representative called a Director by the CFMS to the two yearly meetings. The rules and regulations that the CFMS operate under require a quorum for both yearly meetings. If the quorum is not met, the CFMS simply cannot do business. In 2013 I have had the privilege of attending both annual meetings on the part of the VVGMC. And at both meetings, we met quorum, by only two directors. If two fewer CFMS Directors had not shown up, the CFMS could not have done business in 2013. And that may have led to the loss of the insurance we depend on to protect our club from liability.

The CFMS and our membership with this organization is vitally important to our being able to be the club that we currently are. And even though we all complain about the cost to our respective clubs, it is only through the efforts of the CFMS that our programs, field trips and shows have continued.
